NIH Public Access Policy Compliance Guide

Enacted in April 2008, the NIH Public Access Policy requires that peer-reviewed journal articles authored by NIH-funded researchers and based upon NIH-funded research be submitted to PubMed Central upon publication to be made publicly available no later than 12 months after the publication date.

The NIH has announced that in

Spring 2013 it will begin holding the processing of non-competing continuation awards if publications arising from NIH funding are not compliant with the Public Access Policy (<http://grants.nih.gov/grants/guide/notice-files/NOT-OD-12-160.html>).

PEMSoft Trial

A trial of PEMSsoft, an interactive point of care, library and decision support program for pediatric emergency, critical care and primary care providers is available. The database is organized by assessment categories, diagnostic categories and special interactive modules which include:

- ◆ Resus Tools
- ◆ Calculators
- ◆ Signs & Symptoms
- ◆ Formulary
- ◆ Procedures
- ◆ Quick Reference
- ◆ Triage
- ◆ Toxicology

Thousands of photos, graphics, and videos complement the content. All content is linked so navigation through the topics is seamless.

The Resus(itation) tool and medical calculators allow for individualization of drug doses, equipment sizes and treatment approaches based on the child's length, weight or age.

The information is written by the founding Pediatric Emergency physicians as well as a team of editors and contributors with no commercial support.

PemSoft is updated continuously and all monographs of new topics, updates and current recommendations are based on

review of the evidence based literature.

PEMSsoft is viewable on desktop, iPad, iPhone and Android devices.

DynaMed, a Point of Care Tool, Renewed

DynaMed, a point of care tool for physicians, has been renewed for 2013. This subscription is supported by the Library and Family and Community Medicine.

DynaMed includes 3200 clinical topics with evidence-based summaries. A weekly update is available that provides from 1-

5 articles selected from DynaMed's Systematic Literature Surveillance as articles most likely to change clinical practice.

DynaMed is available from the Library's home page or from most mobile devices.

Mobile installation requires a DynaMed serial number, ac-

cess to the appropriate app store and a Skyscape account. One serial number may be used to connect up to five devices using the same operating system.

New PubReader View in PubMedCentral

Try PubReader, an alternate option for viewing articles in the PubMedCentral archive.

PubReader view improves readability on tablet and other small screen devices. On a tablet, you can flip the pages as in a book. Figures are always immediately available in a figure strip.

PubReader can also be used on desktops and laptops and

from multiple web browsers.

The new view is available for any article that is available in full-text HTML form in PMC.

Several speakers at the 2012 Association of American Medical Colleges (AAMC) featured books prominently in their presentations. The following titles are available in the Library's collection, if you'd like to bring the AAMC meeting to you:

Collins, James C. and Porras, Jerry I. **Built to Last: Successful Habits of Visionary Companies.** New York City: HarperBusiness Essentials, 2002. [HD 58.8 C712b 2002]

From the author of *Good to Great*, this book focuses on selected successful, long-lasting companies and the traits they exhibit compared to their top competitors. Collins and Porras define a company's core ideology as their core values (the organization's essential and enduring tenets) plus their purpose (the organization's fundamental reasons for existence—not specific goals or strategies). Visionary institu-

tions preserve their core while stimulating progress.

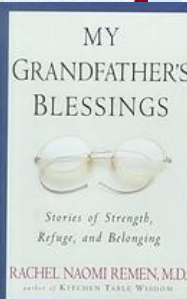
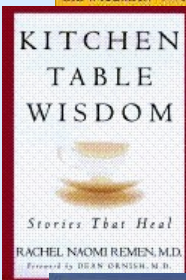
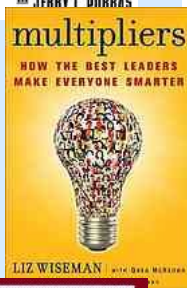
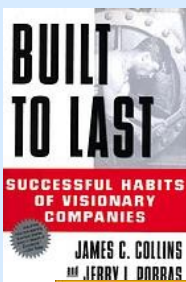
Wiseman, Liz and McKeown, Greg. **Multipliers: How the Best Leaders Make Everyone Smarter.** New York City: Harper Collins, 2010. [HD 58.8 W814m 2010]

Author Liz Wiseman spoke at the AAMC meeting, and AAMC President Darrel Kirch titled his President's Address, "From Moses to Multipliers—the New Leaders for Academic Medicine (for full-text of address: <https://www.aamc.org/download/313270/data/aamcpresidentsaddress2012.pdf>). He suggested that academic medicine (and the country) may no longer need a single great leader ("the sage at the top"), but rather a "multiplier" who makes everyone around them smarter, by being a "genius-maker", not a genius. The book's authors suggest strategies for becoming a multiplier. Asked what

one thing can get someone on the path of a multiplier they respond: "ask really insightful and interesting questions that make people think."

Dr. Remen was the 2012 John A.D. Cooper lecturer at the AAMC meeting. Her talk focused on addressing physician stress and job satisfaction by returning to and nurturing the original calling medical students feel in entering the profession. Dr. Remen's books tell the stories of her patients and their discoveries through their stories (see p. 4 for more from her address).



Highlighted Resource - Journal Citation Reports (JCR)

Journal Citation Reports database, available through [Web of Knowledge](#), provides a variety of journal performance metrics, including Journal Impact Factor, and Eigenfactor®.

JCR can show you the:

- ◆ Most frequently cited journals in a field.
- ◆ Highest impact journals in a field.
- ◆ Largest journals in a field.

JCR is published annually in two

editions:

JCR Science Edition contains data about more than 8,000 journals in science and technology.

JCR Social Sciences Edition contains data about more than 2,600 journals in the social sciences.

The number of articles given for journals listed in JCR include primarily original research and review articles.

Citation and article counts indi-

cate how frequently current researchers are using individual journals. JCR tabulates and aggregates citation and article counts for journal evaluation and comparison.

Use JCR to generate reports that include Journal Impact Factor, Eigenfactor, and other measures of journal influence.

HathiTrust



Records are now appearing in the online catalog for 1.2 million public domain, full-text materials from the HathiTrust, a group of research libraries and institutions that preserve cultural records for future retrieval.

For example, try searching “black history” in the catalog search box on the Library’s home page. Results will include HathiTrust eResources (public domain) in full text.

When using the Advanced Search mode you will find search options for including or excluding HathiTrust eResources under the Limit To section.

1. What surprised me today?
2. What touched my heart today?
3. What inspired me today?

She recommends this technique for "having new eyes."

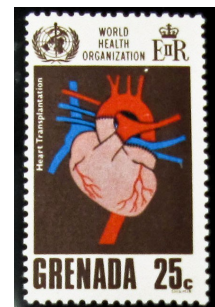
